Below is a Two-Step Guide outlining how to register for the event and fundraising. This simple process takes around 15 minutes in total.



## Step One: Enter the Melbourne Marathon Event

(If you have already registered for the event, go to [Step Two](#) to create fundraising page)

- 1) Visit [www.melbournemarathon.com.au](http://www.melbournemarathon.com.au) and click on your desired race category (e.g. 3km Walk, 5.7km Run etc) under the 'Register Now' tab. Then choose 'Click Here to Register'.
- 2) Follow the prompts to complete registration. (\*If your company has a team, complete the 'Choose a Team' field, otherwise leave blank).
- 3) When you reach the Go Fundraise section, please select 'Another charity not listed here'.

## Step Two: Create an Online Fundraising Page

We suggest all participants aim to raise \$250 each (that's just a \$25 tax deductible donation from 10 generous sponsors).

To set up your personal online fundraising page, follow these simple steps:

- 1) Join your company's team page by clicking the provided company link. Select **Join Team** and follow the prompts to complete your page set up (progress to point 6) below).

OR

To create an **individual** or **new team** fundraising page, (if your company does not yet have a fundraising team or you're fundraising alone), [Click here](#).

- 2) Click **start fundraising** (you will be asked to log in / create a user name), prior to being directed further.
- 3) Once logged in, select **Telco Together Foundation** in the 'Choose your Charity or Cause' field.
- 4) Select **individual** page type if you're fundraising alone, or **team leader** to create a company team page.
- 5) Follow the prompts to complete your page set up and then make a note of the link to your page (to send to potential sponsors).
- 6) Start fundraising – by directing friends, colleagues and contacts to visit your online fundraiser page. Tax deductible receipts are automatically generated by this facility.
